

# Equities Dividend yields and volatility analysis














# Equities S&P 500 Index: YTD analysis






### Asset Allocation Ideas Equity yields around the globe









### Loans & high-yield: swapping rate risk for credit exposure




**10-Year Correlation with U.S. Treasuries**




