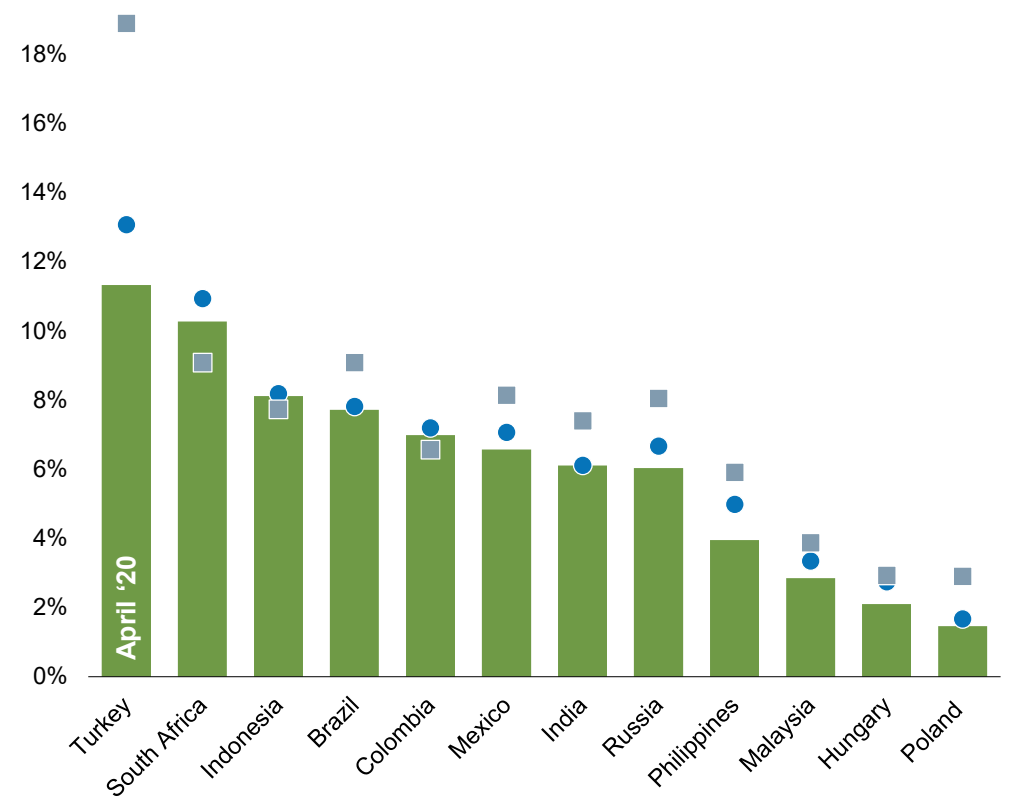

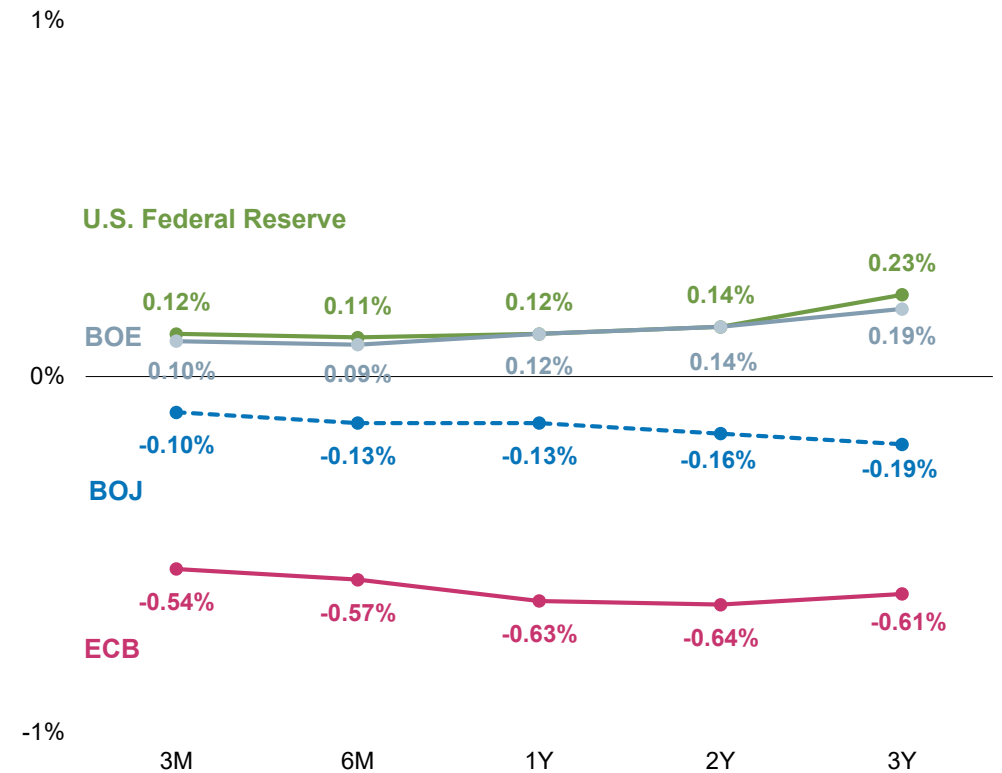

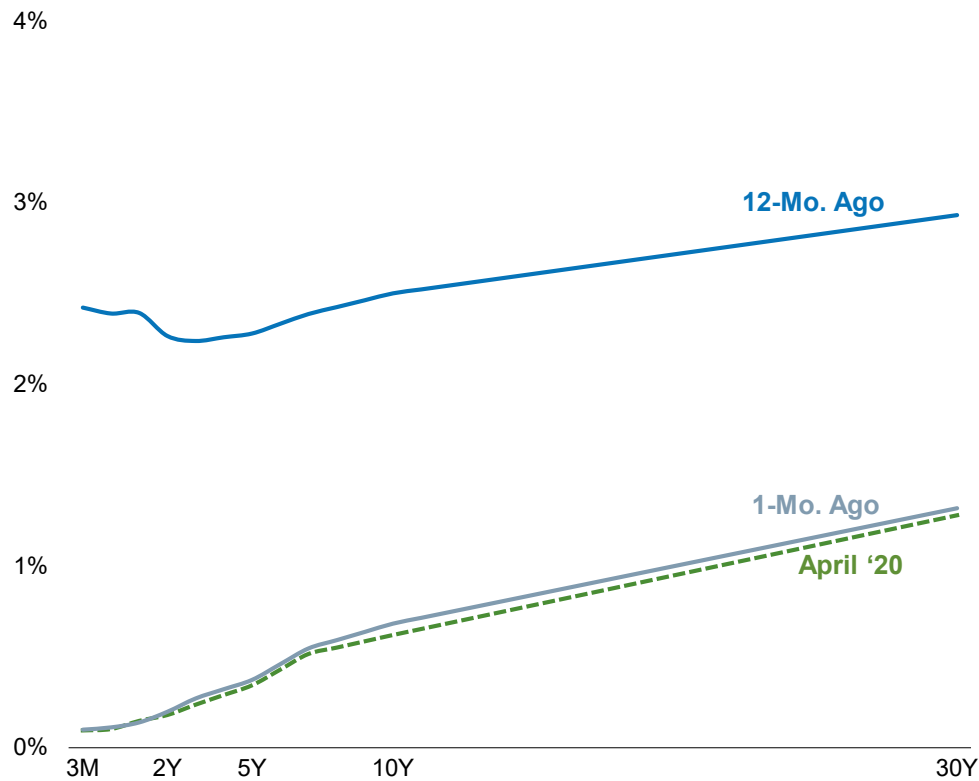
Market Expectations for Future Central Bank Rates

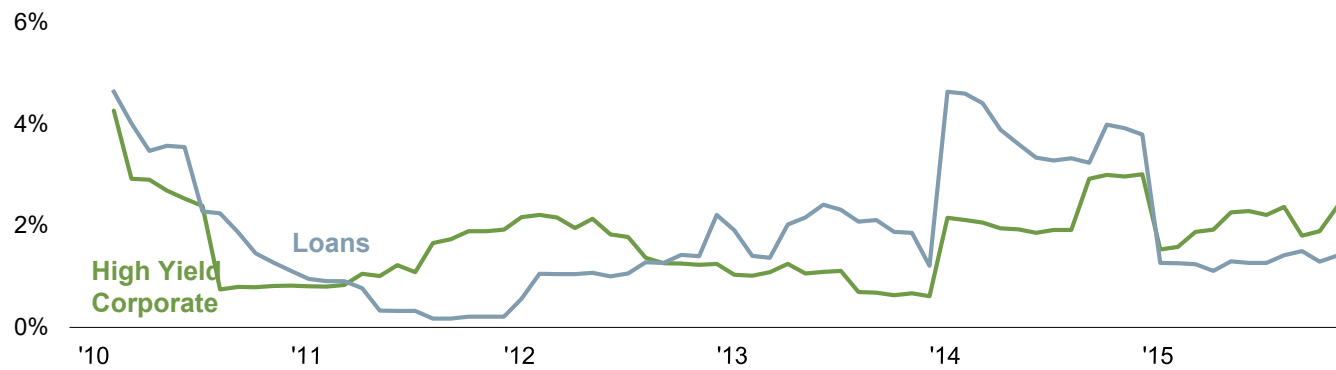

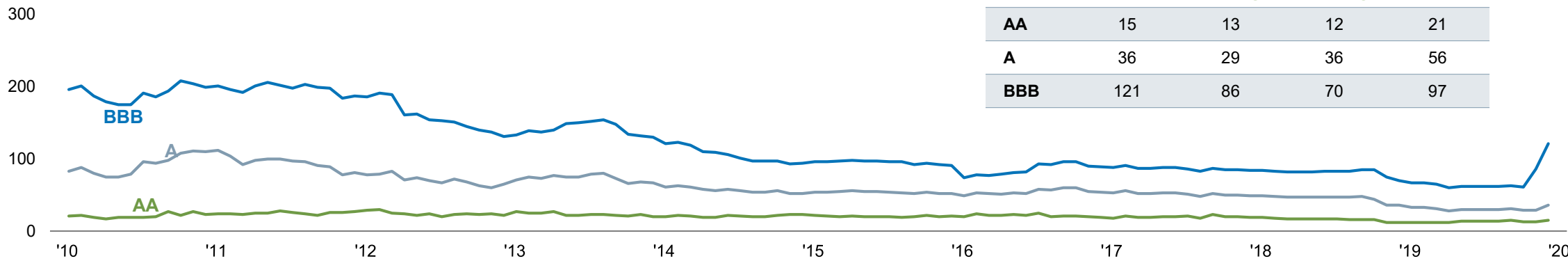

Credit Quality Spreads vs. AAA (bps)



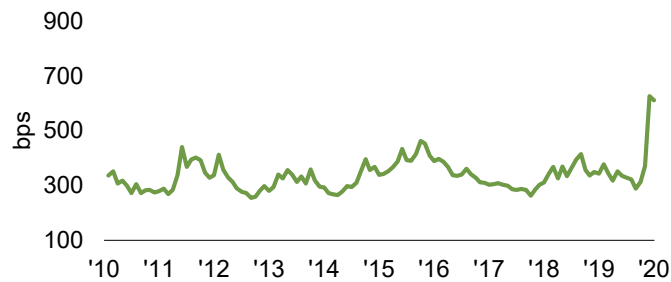

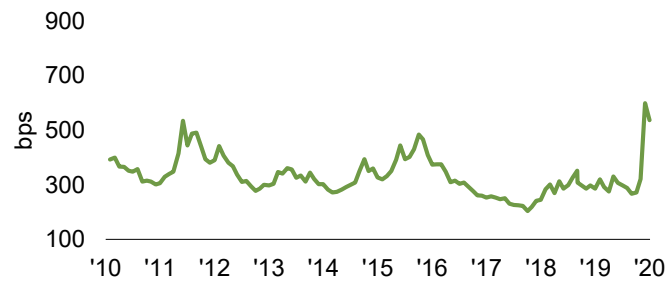

Sovereign EMD Spreads (USD)



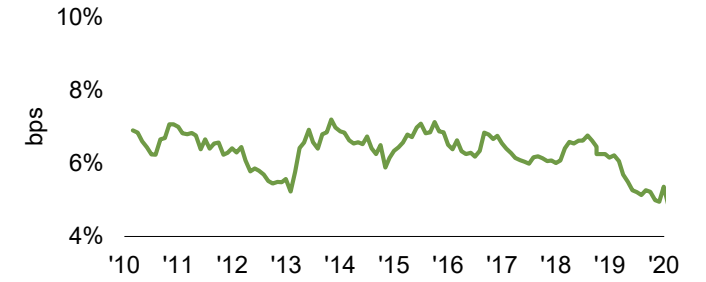

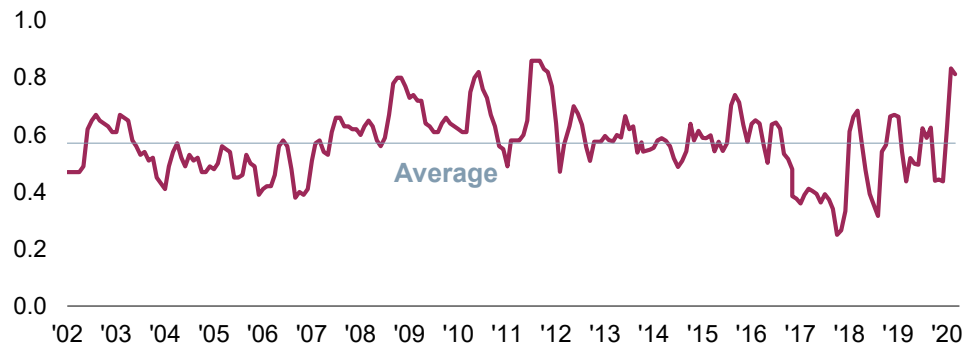

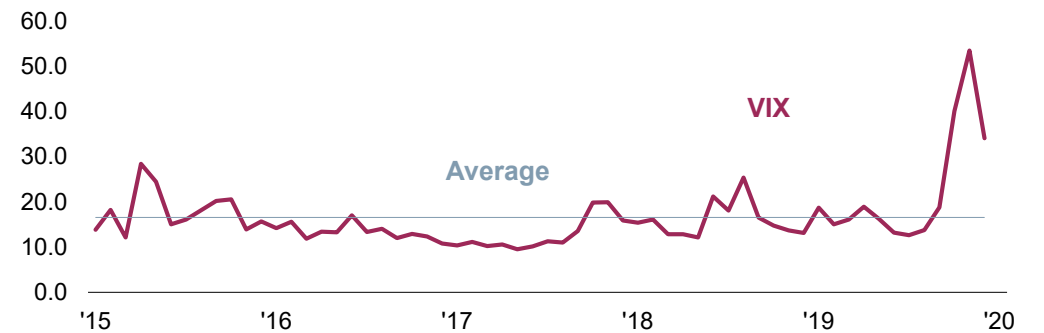

CBOE Market Volatility Index (VIX)

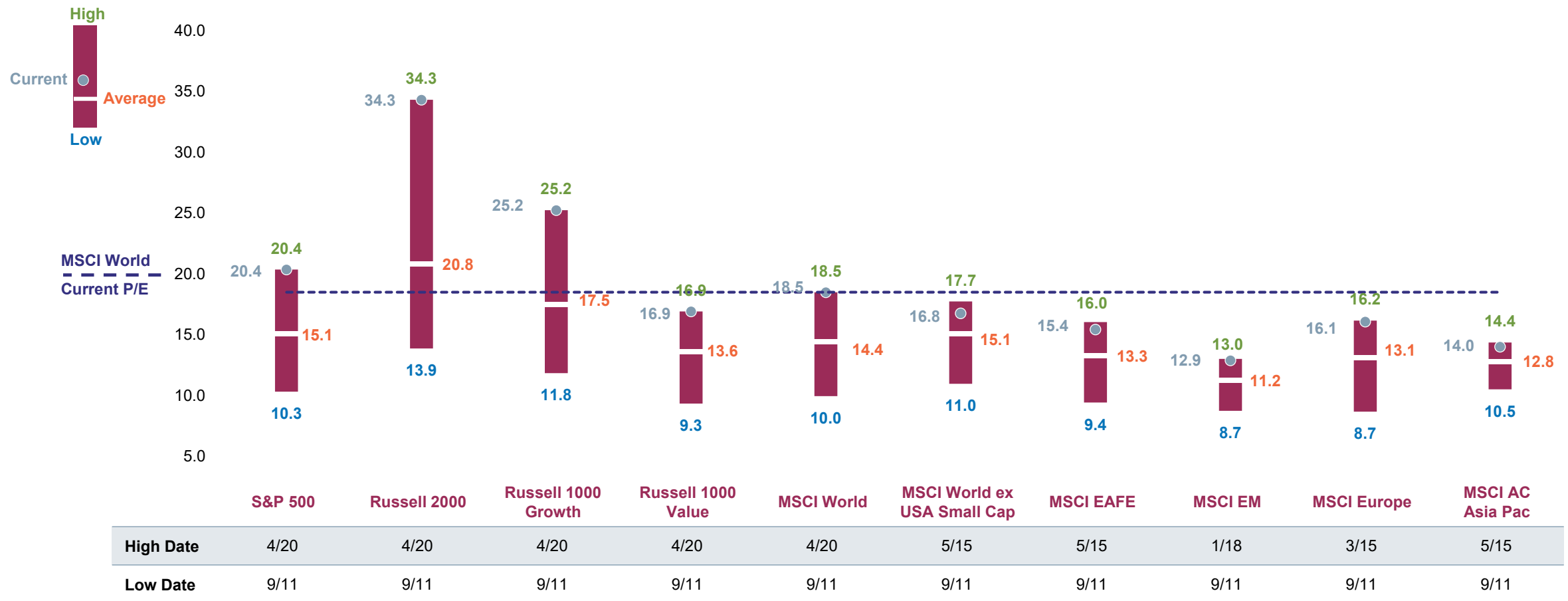

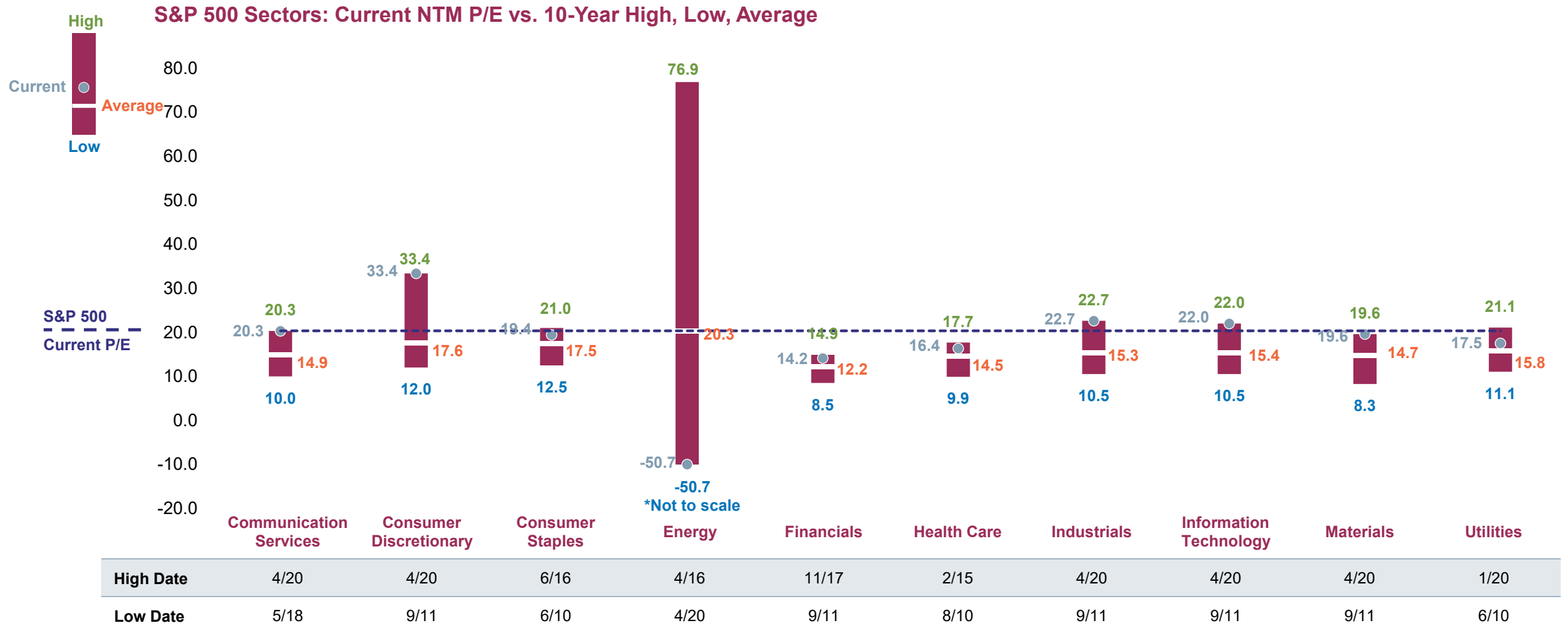
Regions/Styles: Current NTM P/E vs. 10-Year High, Low, Average

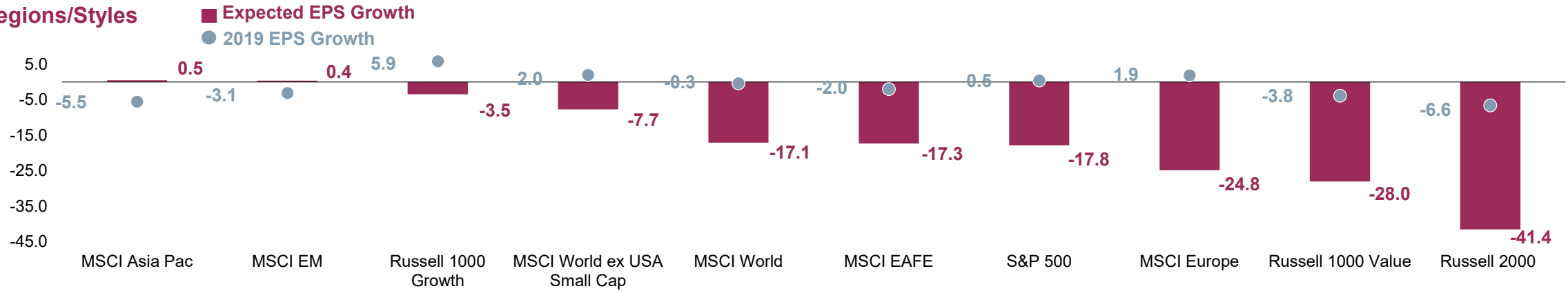

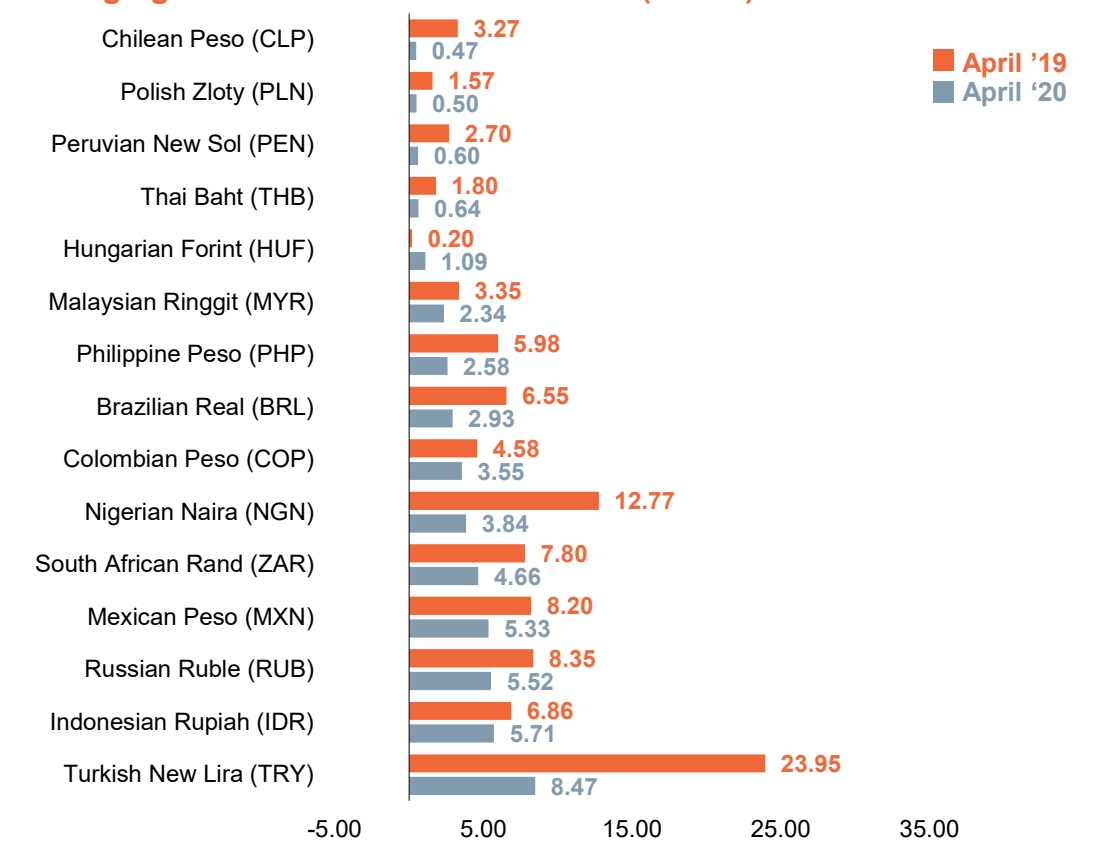

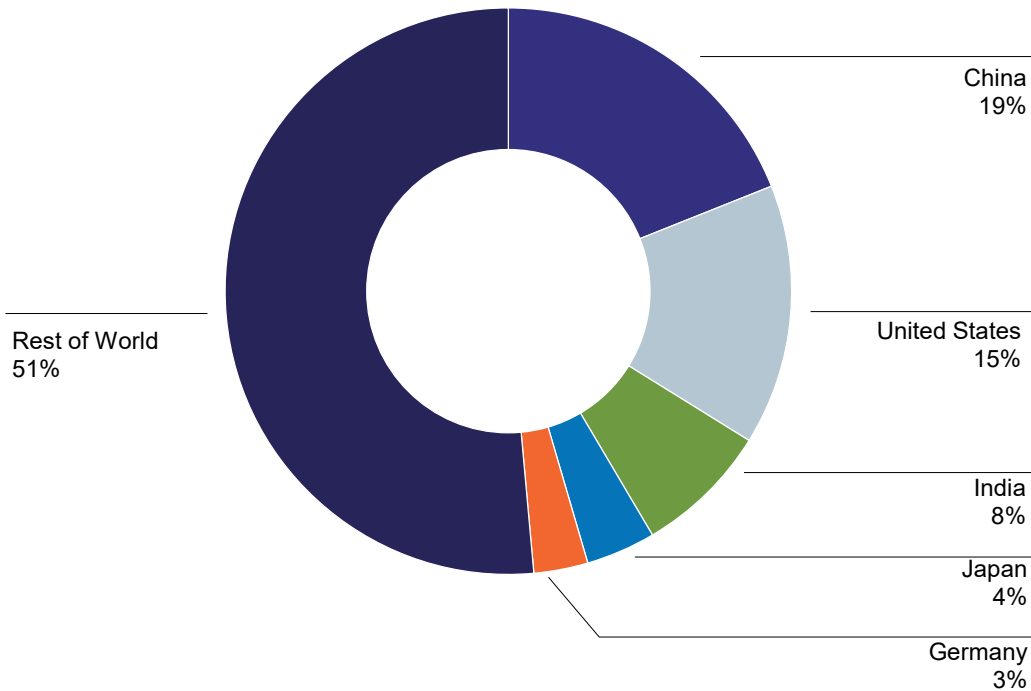

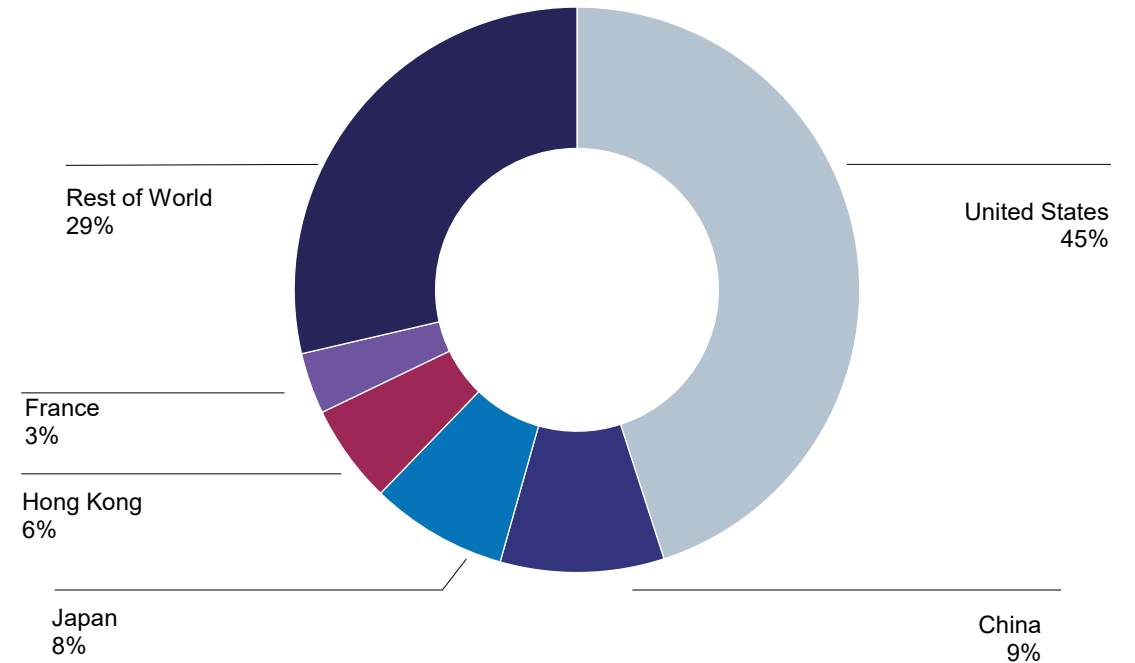

Market Capitalization % of World Total

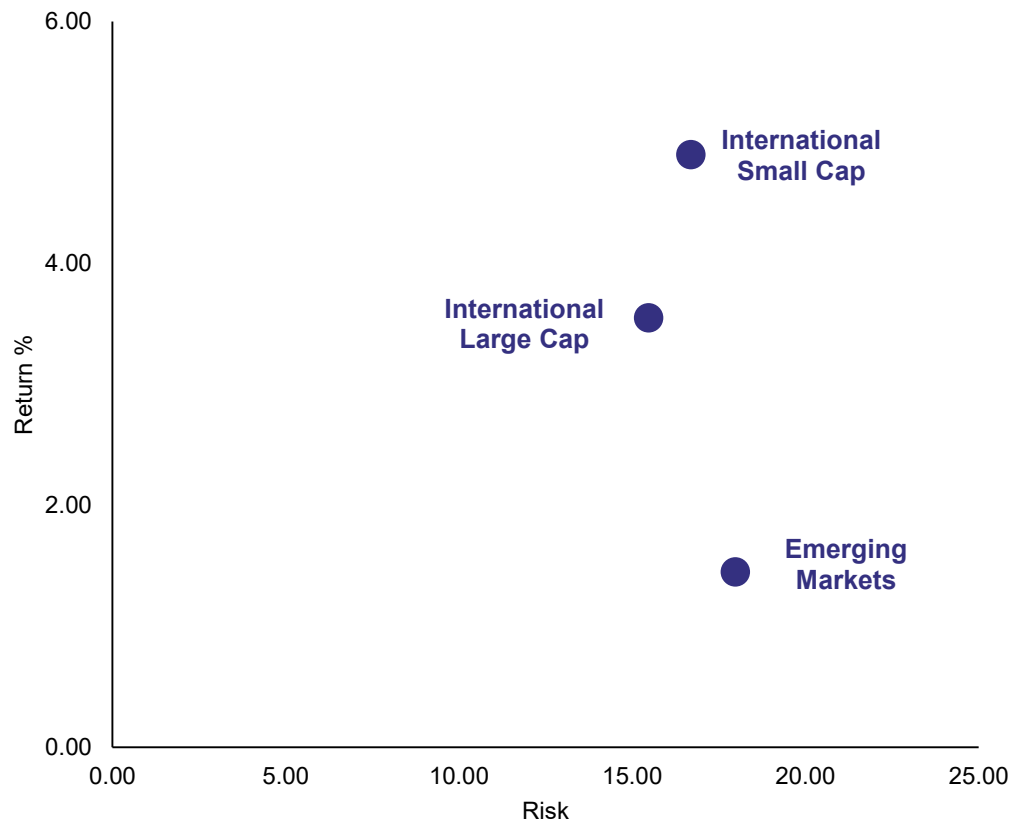

Annualized Risk/Return over 10 years



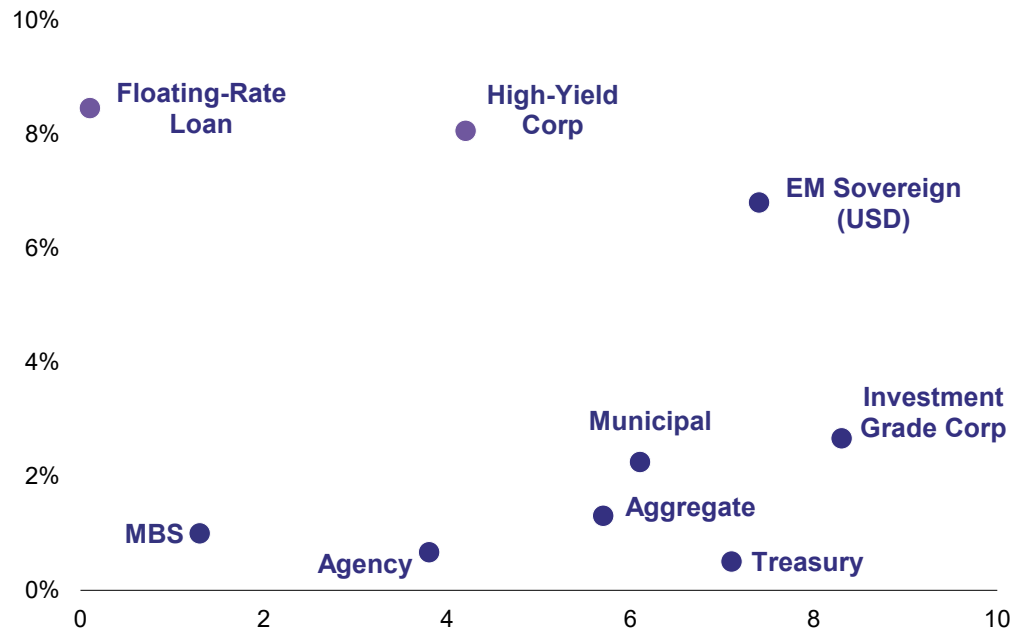

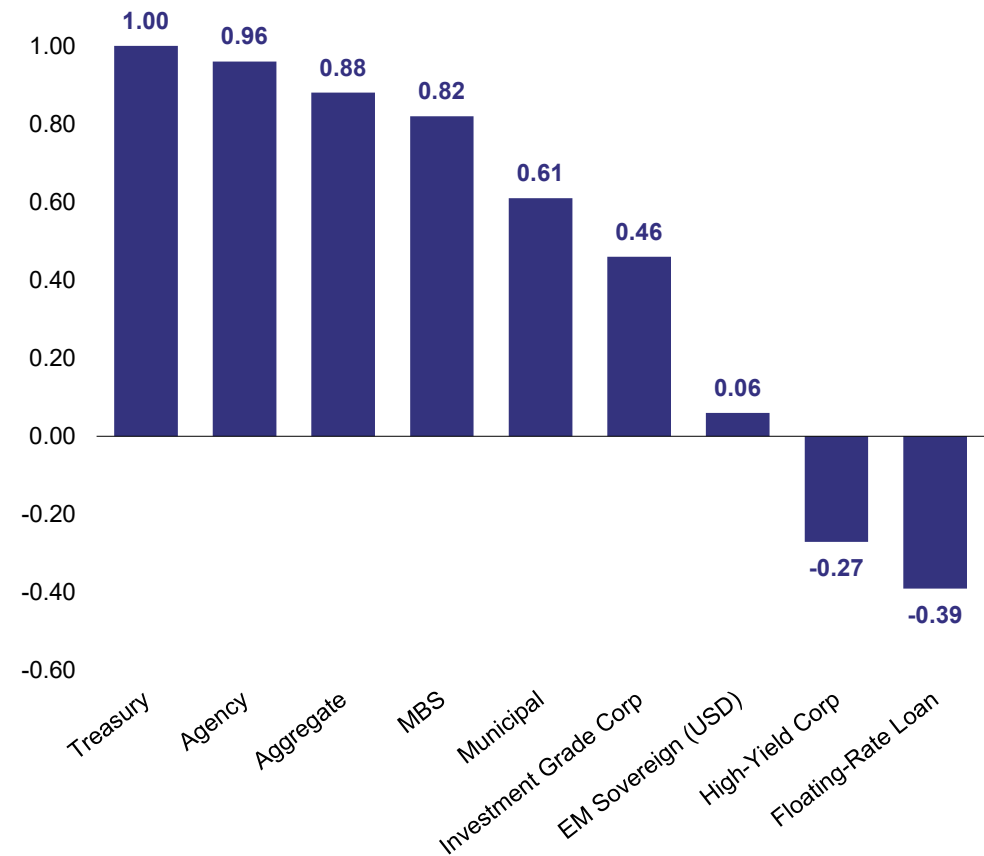

10-Year Correlation with U.S. Treasuries

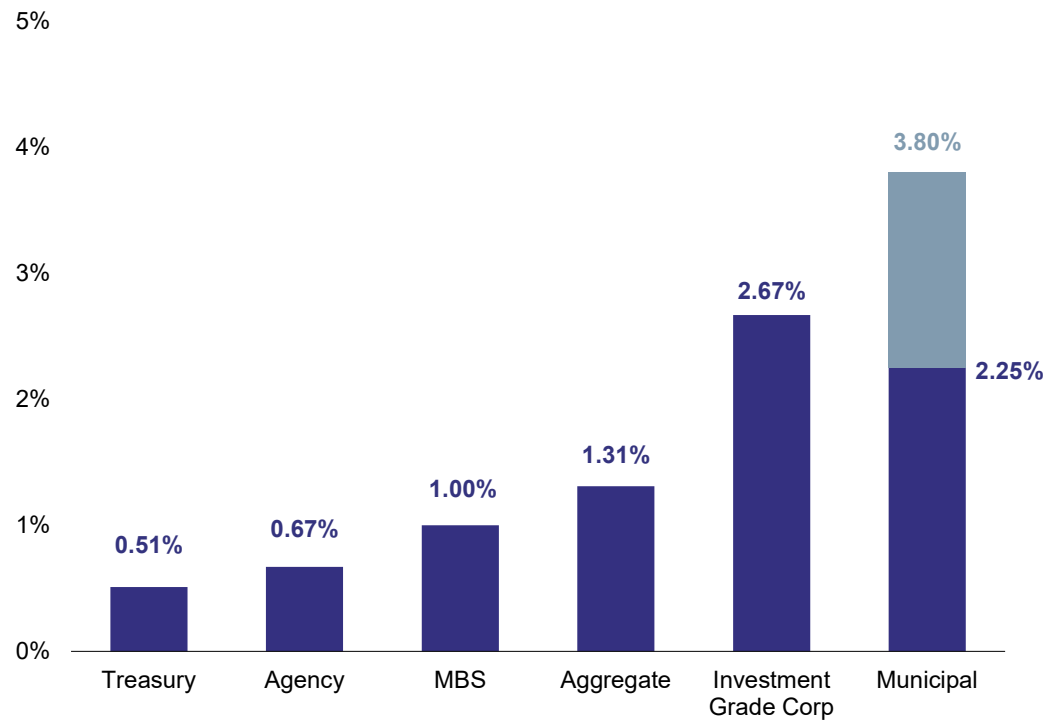

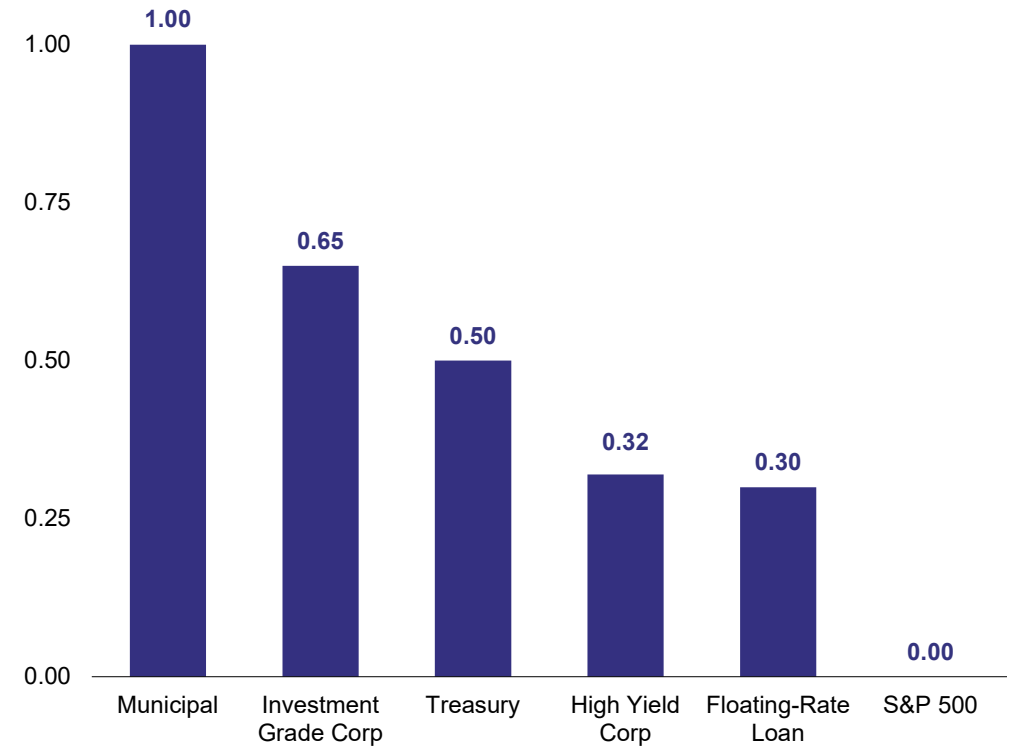

5-Year Correlation with Municipals

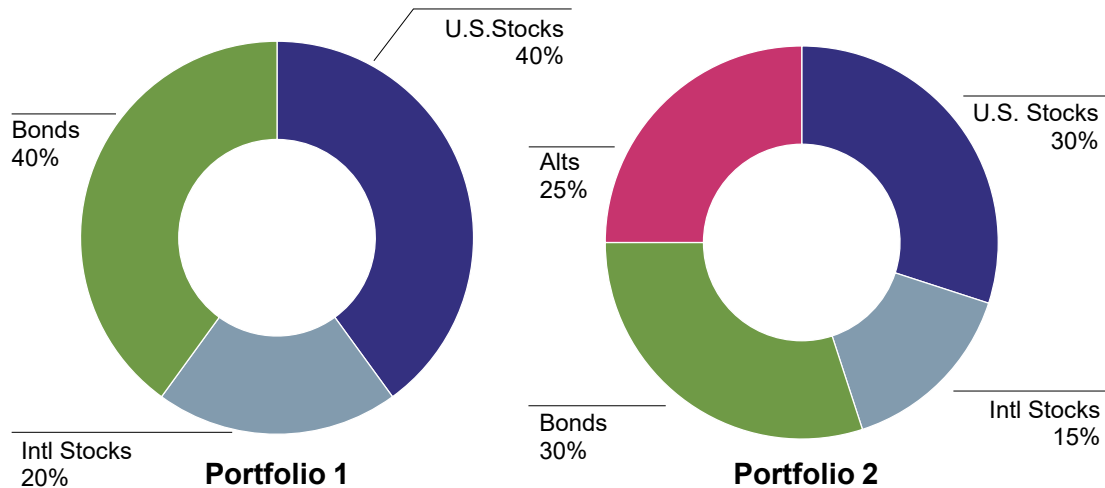

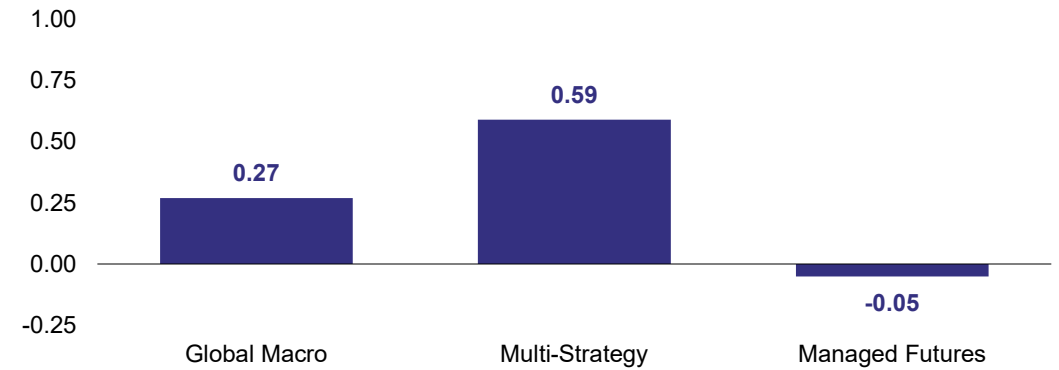

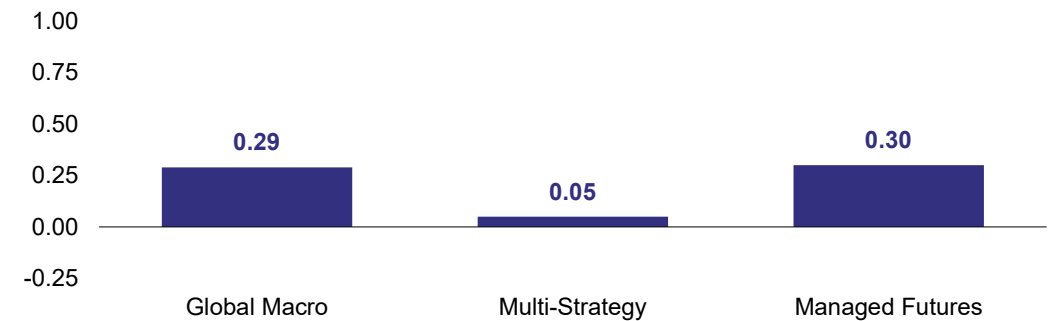
